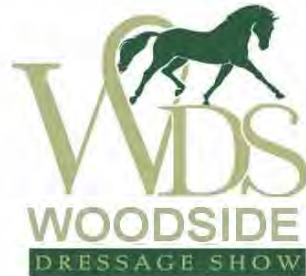

***Great American/USDF Regional Championship Qualifying Classes:** Please indicate that the class is to count for qualifying by placing a "Q" after the class number and pay an additional \$20 USDF qualifying fee. Qualifying will not require a separate ride. Qualifying Classes count towards the 2026 Great American/USDF Regional Championships. Training Level Musical Freestyles are ineligible for qualifying.

~2026 USDF Regional Adult Amateur Equitation Program: Classes #105 and #205 USEF Dressage Seat Equitation can be used as a qualifying for the new USDF Regional Adult Amateur Equitation Program. Adult amateurs may qualify to participate in the program by earning one score of 70% or higher, in any dressage seat equitation class. There is no qualifying fee, or special requirements for submitting results to USDF. For more information about the USDF Regional Adult Amateur Equitation Program, please visit the USDF website.

^Opportunity Classes: Opportunity classes are intended for entry level riders. Horses and riders entered only in "Opportunity" classes are exempt from USEF and USDF membership requirements, and do not have to pay non-member (show pass) or HID fees. Federation and drug fees do not apply, though they must pay the CA Drug fee. Horses entered only in these classes are still subject to and must comply with the Drugs and Medication rules and are subject to drug testing. Riders and/or horses entered in opportunity classes may not cross enter into other recognized classes at the show. Participants must abide by all USEF regulations pertaining to attire, tack, and equipment for the recognized show. Reference USEF rule GR821 for additional information.

SAFESPORT REMINDER

All USEF Life and Senior Active Members, as well as participants who have contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirements to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF SafeSport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

TIPS ON SUBMITTING A COMPLETE ENTRY

Entries must be submitted electronically through Fox Village Online Entry portal. Exhibitors can avoid the **\$25 Incomplete Entry Fee** by submitting **ALL** of the documents detailed below via the Fox Village Online entry system.

An entry is considered complete only when all the required forms that include the names of all parties - Rider/Owner/Trainer/Coach/Parent (if rider is a minor), correct and current USEF, USDF and CDS membership numbers, signatures on required forms, coggins and vaccination documentation, and fees have been received in full.

- The entry form must include the name of horse (which must match the coggins and vaccination record, per GR906.4), rider, owner, trainer, and coach (if applicable).
- Horse name must match from USEF to USDF.
- USEF, USDF and CDS Memberships must be current and active for each person listed on the entry, as well as the horse.
- SafeSport training must be current and not expired (minors exempted).
- The USEF Federation Entry Agreement must be **signed***** by **ALL** of the following parties: Rider/Owner/Trainer/Coach (and Parent if rider is a minor) on same form. Signatures on the USEF Federation Entry Agreement must match the entry form, i.e., if the coach is Sally Jones, but the entry says Michael Smith, it does not match.
- The USEF Waiver and Release of Liability must be **signed***** by **ALL** of the following parties: Rider/Owner/Trainer/Coach (and Parent if rider is a minor). This may require more than one signed waiver for each entry.
- The Horse Park at Woodside Liability waiver must be **signed***** by **ALL** of the following parties: Rider/Owner/Trainer/Coach (and Parent if rider is a minor). This may require more than one signed waiver for each entry.
- ***** All signatures** must be handwritten or e-signatures, no typed accepted
- Official proof of vaccination records showing horse(s) has been vaccinated for Equine Influenza, EHV-1, and EHV-4 within 6 months (180 days) of the stable entry date. **Reminder, the horse(s) name on the entry form must match the vaccination record, per GR906.4.**
- For out-of-state horses only, official proof of negative coggins record within 1-year of the stable entry date. **Reminder, the horse(s) name on the entry form must match the coggins, per GR906.4.**

The USEF Federation Entry Agreement and USEF Waiver and Release of Liability can be signed electronically within the Fox Village Dressage entry portal. These documents can also be uploaded along with other required documents. Please be sure that the USEF Entry Agreement and USEF Waiver and Release of Liability are the current versions of the form (a copy of these forms is included within this Prize List and can be found on USEF website).

UPDATED USEF MICROCHIP RULE

As of January 12, 2026, the USEF Microchip rule has been modified extending the deadline for the requirement to be **December 1, 2026**. See the updated rule below.

GR1101 Horse Identification Number and Horse Identification Form 10. Effective December 1, 2026, all horses competing at Federation Licensed and Endorsed Competitions must provide a microchip number that verifies the animal. A microchip used to verify identity must be a fifteen-digit ISO compliant 11784/11785 chip and be implanted in the nuchal ligament of the animal. See breed or discipline rules regarding specific microchip requirements as those rules and requirements remain in effect.

All questions not covered by these rules and regulations shall be decided by the Show Management and such determinations shall be final.

✓ Owner/Agent/Participant agrees that every horse entered, or which they bring to the show grounds, will be subject to the rules of the Horse Show management. However, Show Management will, in no case, be responsible for any loss or damage that may occur to any horse entered or on the grounds, and it shall be a condition of entry that each exhibitor agrees to defend, indemnify and hold harmless the United States Equestrian Federation, the United States Dressage Federation, the California Dressage Society, the San Francisco Peninsula Chapter, the Horse Park at Woodside, any additional recognizing organizations, the facility at which the event is held (showgrounds), the horse show and its management, employees, volunteers and independent contractors for any loss or accident to his horse, horses or equipment which may occur.

✓ All Owners and Exhibitors will be held responsible for any damage incurred by them, their agents, employees or animals to stall buildings and other properties on the show grounds and shall be billed accordingly. All bills for veterinary, farrier services and feed are due and payable during the show. The management reserves the right to deduct any unpaid veterinary, farrier and feed bills from premium, stake or prize money, or refunds due the exhibitor. Any exhibitor not meeting obligations to the veterinarian, farrier or feed supplier will be termed an undesirable exhibitor and entries from that exhibitor may not be accepted at subsequent shows. Competitors are responsible for all **INSURANCE** for themselves, employees, owners, horses, etc.

✓ Liability – Horses by their inherent nature present a risk. This show, the management, the USEF Licensee, and the facility will not be responsible for any loss or damage or injury to horses exhibited, or for any article of any kind or nature that may be lost or destroyed, or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned to any person, whomsoever, by any horse owned or exhibited by said exhibitor and shall indemnify the show, the management, the show committee and volunteers, the USEF Licensee, the USEF and USDF, or any member thereof, against all claims and demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of any such horse. All horses exhibited in this show participate entirely at the owner's risk. Neither the Organizing Committee, show volunteers and staff, the facility or its owners, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses, or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date. Additionally, the San Francisco Peninsula Chapter, the Horse Park at Woodside, and their officials, sponsors and employees will not be responsible for any accident or loss which may occur to any exhibitor, spectators, guest, rider, groom, attendant or other employee, animal, or equipment at any of the competition.

✓ Current USEF, FEI, USEA and USDF tests will be used.

✓ USEF General Rules define the protest procedure.

✓ An Exhibitor's Letter with updates may be included with the riding times. Information in this document is considered to be as binding as any other rule or procedure stated in this Prize List.

✓ No one may ride a horse on the show grounds unless they have signed the horse's entry blank as rider, owner, trainer or coach

ENTRIES - SCHEDULING - RIDING TIMES

✓ Entries will be accepted on a first-come basis and must include all fees, membership and horse registration proofs, signatures and payment. *Numbers will not be released until this process is complete; entries without payment in full may be returned.* Entries must be received by midnight of the Entry Closing date in order to avoid late fees. Entries that are received, complete with payment, signatures and proofs will have priority over e-mailed entries. Entries submitted by email are considered to be legal contracts and are subject to all of the rules of the show, including post/late entry fees. If the show has extended the courtesy of accepting a late or emailed entry, the responsible party will be liable to pay all class, office, stable and other fees. Withdrawing at any time will not excuse the responsible party from paying all of the applicable fees. Those who do not comply with this will be turned in to the recognizing authorities and no future entries will be accepted until the matter has been resolved.

✓ Management will close the show when it is full and place excess entries on a wait list. Entries that have arrived after the show is declared full and prior to the printed entry closing date will not be subject to late fees. Any entry emailed or submitted online after the published entry closing date is considered a post entry and all post entry and late fees will apply.

✓ Post entries allowed on a space available basis only, prior to the start of the class and after all forms have been completed, signatures obtained and fees paid. A late/post entry fee will be applied to all post entries. All change requests must be in writing and accompanied by a blank check, credit card or cash to cover the cost of the class(es) requested. If the change is granted, the usual class and post entry fees will be charged

✓ Copies of all membership cards and horse recording certificates are required. The requirements of USEF, USDF and CDS will be strictly followed and the show will collect fees for any individual or horse registration that is required and cannot be proven by presentation of the current card. To enter the Adult Amateur Division, the USEF Membership card MUST indicate Amateur and the individual must reach the age of 22 in the current year.

If you do not submit proof of Adult Amateur status, you will be entered in the Open division. If you request to switch to Adult Amateur classes after entry closing, all post entry and/or change fees will be applied if this requires that you be rescheduled.

✓ Post entries allowed on a space available basis only, prior to the start of the class and after all forms have been completed, signatures obtained and fees paid. A late/post entry fee will be applied to all post entries. All change requests must be in writing and accompanied by a blank check, credit card or cash to cover the cost of the class(es) requested. If the change is granted, the usual class and post entry fees will be charged

✓ Classes will be scheduled to accommodate the judges, riders and management. Rider scheduling preferences, if noted on the entry, will be indulged when possible. The 25-minute rule between rides on the same horse will be observed. The 50-minute rule between rides will be observed for riders of multiple horses. Requests for specific break parameters will be considered, but not guaranteed. Classes will not necessarily be scheduled in order of difficulty. There will be two or more rings running most of the days. In general, FEI tests are scheduled in the morning, lower-level tests in the afternoons. Start time is 7:30 to 8:00am.

✓ **Provisional ride times will be POSTED ON WWW.FOXVILLAGE.COM and WWW.SFPCDS.ORG.** It is the obligation of the entrant to contact the Show Secretary at mmmdressage@gmail.com if times have not been received. Scheduling conflicts must be emailed to the Show Secretary 48 hours prior to the start of the show. **Next day's revised schedule is posted on www.foxvillage.com.**

SHOWGROUNDS:

✓ DOGS must be on a physical leash less than 6 ft long at all times and owners must be able to provide proof of current rabies vaccination. No extendable leashes allowed. Dog owners failing to comply with this rule may be subject to penalty under Facility, Show and USEF Rules. The issuance of warning cards is a possibility. Additionally, there is a minimum fine of \$100 per occurrence and owner may be refused entry into future shows. Any damage whatsoever that is attributed to the dog is the complete financial responsibility of the owner of the dog.

✓ All classes are planned to be held in the large (20mx60m) arena unless the small arena is mandated by the test. Appropriate tests may be held in the small arena IF there are scheduling or weather problems. Footing is sand or sand/fiber in all competition, warm-up and lunging arenas. If weather conditions permit, separate lunging area will be available. It may be subject to posted hours of availability.

✓ The assigned bridle number must be worn or displayed at all times when the horse is on the grounds and/or out of the stall.

✓ Use of the warm-up arenas during show hours is limited to those who are entered in the show and, at the discretion of Show Management, will be restricted to those warming up for class(es) in progress when there is congestion. **NO ONE ON FOOT WILL BE ALLOWED IN THE DRESSAGE WARM-UP ARENAS AT ANY TIME.**

RV PARKING & ACCOMODATIONS

✓ RV hook-ups; please reserve on your electronic or emailed entry or by emailing mmmdressage@gmail.com

AUTOMOBILE PARKING

✓ Parking is allowed in designated areas only. Violators improperly parked, including NO PARKING ZONES AND FIRE LANES, will be issued Citations and/or towed from premises at the vehicle owner's expense. (U.S. Mun. Code – 80.71-4/CA. Veh Code 22658A)

STABLING - GROUNDS

✓ Owner/Agent/Participant agrees that show management is merely providing stabling for the convenience of the participant and management and sponsoring organizations shall have no responsibility whatsoever for any injury, loss, damage, etc., as a result of using said stabling. Owner/Agent/Participant agrees to indemnify, defend, and hold Show Management, their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations harmless from any loss, damage or claims as a result of said use. **Owner/Agent/Participant assumes all care, custody, and control with regard to this use.**

✓ The Stabling Request MUST be completed and paid for with entry. **Once ordered, there is no refund for stabling after initial closing date.** Stalls are 10X12 with bottom doors, with electricity. By renting a stall at the Horse Park you agree to abide by the stall use policies. Stabling will be assigned in order of receipt of entry, with consideration for requests made on the entry. Fees apply whether the stall is used for a horse, tack, dog, feed or grooming. Stall may not be reassigned, sublet or sold. Stabling is available from one day prior to the start of the show through the final day of the show. An additional day(s) of stabling both before and after the show is subject to availability and must be requested with secretary directly. An additional fee is required per additional day per stall. Trailers entering stable area shall enter on the North side and exit on the South Side

✓ Order feed and bedding through online or emailed entry or by contacting show secretary mmmdressage@gmail.com. Orders place at competition must be before 11:00 am for same day deliver. **NO OUTSIDE BEDDING ALLOWED!** There is a minimum of 3 bags of bedding per all overnight horse stalls. **NO straw bedding is allowed!**

✓ Wash racks are available.

✓ Haul In's allowed with a Grounds fee per day on grounds and/or day stall. Manure removal fee will apply to all horses.

EXHIBITOR IS RESPONSIBLE TO INSPECT STALL AND REPORT PRE-EXISTING DAMAGE PRIOR TO USING STALL.

- ✓ Cost of repair for any damage or defacement of property will be charged to the Exhibitor.
- ✓ Please deposit all manure at the end of the barn aisles or as designated by the facility. Waste materials must be disposed of properly, in accordance with State law and the rules of USEF.
- ✓ **NON-COMPETING HORSES.** Each non-competing horse must be entered and have signed releases, wear an assigned number, must observe the rules governing the use of warm-up areas and must pay the required fees, including but not limited to stabling, manure fee and grounds fee. Any horse brought onto the grounds, including the parking lots, is subject to the rules of the show. This includes horses that never leave a horse trailer. Violations of these rules will result in double the fees due. Priority in availability, location and type of stabling will be given to competing horses. No horses under the age of 3 years are allowed on the competition grounds.
- ✓ Any balance due at the end of the show will be billed and subject to a billing fee. Payment must be made immediately upon receipt of the bill. Non-payment will result in the individual being turned in to the sponsoring organizations, in addition to all legal ramifications.
- ✓ Arena lights may only be turned on or off by The Horse Park staff or the show manager.

REFUNDS - CANCELLATIONS

✓ **REFUND REQUESTS MUST BE IN WRITING AND SIGNED- NOTICE BY EMAIL IS ACCEPTED.** Refunds for cancellations made prior to the original, published, stated entry closing date will be made in full, less a processing fee/office fee. No refunds given after closing date for any reason, including acts of God, weather, etc. Refund of USDF Qualifying Fees: Scratches prior to show in which a full refund (less processing fee) is being made WILL include any USDF Qualifying Fee paid. Scratches that do NOT qualify for a full refund will NOT be refunded any USDF Qualifying Fees. Non-refunded USDF Qualifying Fees will be paid to USDF per USDF rules. No refund of USDF Qualifying fees for scratches made day of show.

There will be no refund for stabling after initial close of entries. There will be no refunds of any sort (including but not limited to drug, class, office and association fees) for same day scratched or no shows.

✓ Checks returned by the bank or credit cards that are refused will be assessed a minimum fee or the bank fees (whichever is higher) upon the first return and will not be run through a second time. A cashier's check or cash will be needed to clear the entry.

✓ **CANCELLATION:** Shows will be held rain or shine. In the event that all or part of the competition is cancelled due to a storm, accident, air quality or other acts of God outside of show management's control or any other emergency, the competition will not be responsible for refunding entry, stabling, office or any other fees,

✓ **PONY MEASUREMENT:** Veterinarian is on call. Please submit a request to measure your pony by the initial closing date. In general, measurements will take place on the afternoon of the 1st day of the show. If this does not work for all involved, a mutually compatible time to measure will be arranged. It's possible the on-call vet may need to attend to an emergency and the measurement need to be rescheduled. Pony owner responsible for vet charges up to \$150.00.

AWARDS - PRIZE MONEY - FREESTYLES - MISCELLANEOUS

✓ **AWARD CEREMONY** procedures will be updated and posted at the Show and Award Offices. Show management reserves the right to amend award information by making notification in subsequent advertising and communications such as exhibitor letters and show programs.

✓ **RIBBONS & AWARDS** Ribbons to 6th and First Place prize for each division if 3 or more in division. All classes will be placed according to Division (Open, AA, Jr/YR). High Point awards (will be awarded for high scores Friday and Saturday with an overall high point given at each show on Saturday for Friday/Saturday combined. No awards will be given for Sunday and ribbons/awards will **not** be mailed.

✓ **SCORED TESTS** will be given only to riders or their agents and only after the results are finalized and the class is placed. Any disputes concerning scores, divisions entered (AA, JR/YR, Open), and/or placings must be brought to the attention of the Show Office within one hour of the end of the show day. Scores and placings become final at that time. Tests not picked up will be discarded. A self-addressed stamped envelope is required for a test to be mailed.

✓ **FREESTYLES:** It is the responsibility of the exhibitor to have the cued music at the announcer's stand at the start of the ride and a representative at the stand to tell the announcer when to start and stop the music. A sound check will be conducted at approx. 3:30pm the day before competition starts. If this does not work for you, please make arrangements directly with the announcer. Exhibitors are responsible for retrieving their own music after the class. A photocopy of the test verifying eligibility must be submitted with the entry for a freestyle class. See DR129.9 for more information. Licensing rights for use of music is the responsibility of the rider. Music should be emailed to both the announcer, Jonathan Horowitz at jhorowitz@gmail.com and cc'd to the show secretary at mmmdressage@gmail.com.

✓ **BITS AND BRIDLES:** There is a new DR126.1a rule concerning equipment checks. Exhibitors must present bridles and bits, if and when requested, to the technical delegate for inspection utilizing the methods, timeframe(s) and locations(s) identified by competition management with the agreement of the technical delegate. These methods must be communicated to the competitors prior to the start of the competition. The technical delegate must inspect at least 50% of the bits and bridles of horses entered in the competition. Technical Delegates must also conduct random ringside bit checks immediately after rides are completed, some of which can be included in the 50% using a new disposable protective glove on each hand for each horse.

JUNIORS

✓ All minors/juniors must be supervised by their parent/guardian or authorized agent at all times while at or on the show grounds, whether riding or on foot. The parent/guardian or authorized agent shall assume all responsibility to protect juniors from any injury, damage, harm and/or loss and shall indemnify, defend and hold show management, its employees, independent contractors and volunteers, the facility at which the event is held, Woodside Dressage Show, The Horse Park at Woodside and all affiliated organizations harmless therefrom.

✓ **Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above de-scribed motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.**

ALL COMPETITORS

✓ **Protective Headgear.** DR120.1.1 Protective Headgear. Protective headgear in compliance with the accepted testing standards published on the Federation's website. Protective headgear must carry the applicable quality testing tag and/or label. See GR801. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes, and those competing in all classes and tests, including Para Dressage tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. The harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until the headgear is properly in place. Protective headgear may be the same as or a coordinating color with the coat, and may include contrast coloring, accent, and crystal decoration. See DR136 for dress code rules for exhibitions.

It is the responsibility of the rider, or the parent or guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use, and is properly fitted and in good condition, and the Federation, Show Committee, and Licensed Officials are not responsible for checking headgear worn for such compliance. The Federation, Woodside Dressage Show, The Horse Park at Woodside, make no representation or warranty, express or implied, about any protective headgear, and cautions riders that death or serious injury may result despite wearing such headgear as all equestrian sports involve inherent dangerous risk and as no helmet can protect against all foreseeable injuries.

✓ **SHARPS. Sharps containers will be placed on the end of each barn. A sharps container is also available in the office. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments**

✓ The dressage equipment rules will be in place from the moment of arrival on the grounds and will be in force for the duration of the show. See DR121.

✓ **Safe Sport.** USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

✓ The Horse Park at Woodside is not responsible for any equipment, boxes, miscellaneous materials shipped to the facility.

✓ No drones to be operated on The Horse Park at Woodside grounds during the show.

✓ Before videotaping any horses and/or rides, you must have owner/rider permission.

✓ Bicycle and or scooter riders must wear a helmet at all times.

✓ Electric bikes, electric scooters and golf carts can only be operated by someone 16 and over with a driver's license

STATE BORDER CROSSINGS:

√ The most recent information available on documents necessary for transporting horses across state lines is available at the following numbers: Nevada Department of Agriculture - (775) 688-1180, Oregon Department of Agriculture 503-986-4680 and California Department of Agriculture (916) 654-1447. Be sure to ask if there are any prohibitions against feed as well.

Equine Health Entry Requirements

Equine diseases are known factors that could potentially impact the Organizer's ability to run competition as scheduled. USEF and the EDCC offer a notification system to advise of equine diseases that could affect your participation in a licensed competition. If the competition is cancelled due to a mandatory quarantine by CDFA or USDA prior to the closing date, competitors will receive a refund of all show fees less \$100.00.

Proof of vaccination for Equine Influenza and EHV1/EHV4 (Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis)) within 6 months of arrival, must be provided before entering the show grounds. See GR844 for additional information.

DURING COMPETITION: ALL HORSES STABLED ON THE SHOW GROUNDS – ARE REQUIRED TO HAVE THEIR TEMPERATURE TAKEN TWICE A DAY! This is mandatory. A Temp Log will be emailed to all exhibitors with additional copies available given at check in - it must be posted on your stall/ trailer and you MUST Temp your horse twice per day - 1X AM - 1X PM. BRING YOUR OWN HORSE THERMOMETER – as Temps must be taken – those not adhering to the stipulation will be asked to leave the competition. Febrile horses (temperature > 101.5) or horses showing any clinical signs of illness must be reported immediately to show management/veterinarian. The competition management reserves the right to extend the taking of temperatures to prior to arrival and will notify exhibitors of this requirement by email.

ALL MEMBERSHIP NUMBERS must be present ***at time of entry submission*** & ALL OTHER DOCUMENTATION (USEF Federation entry agreements, USEF Waivers & Facility waivers, with all signatures (either wet or e-signed), and proof of vaccination must accompany entry or be emailed to mmmdressage@gmail.com by original close of entries or a \$25.00 incomplete entry fee will be charged.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF INHERENT RISKS: I understand and acknowledge that equine activities, including but not limited to horseback riding and equestrian sport, are rugged adventure recreational sports and I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with equine activities and know that these activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS – PLEASE READ CAREFULLY BEFORE SIGNING**

The undersigned, as a Participant/Spectator/Visitor/Volunteer/Member (collectively "**Participant**"), on his/her own behalf and, as the Parent/Legal Guardian of a minor Participant (all included as "**Participant**"), for good and valuable consideration, agrees to the following terms and conditions of this Release, Waiver, Hold Harmless, Defend and Indemnification Agreement ("**Release**");

1. Assumption of Risk and Waiver: Participant understands and accepts the risks of engaging in Equine Activities, as well as merely being near a horse or pony (collectively "**equine**"), including, illness, injury, death, property damage, or any other loss (collectively "**Loss**") resulting from faulty tack and equipment, a failure of Released Parties to make a reasonable and prudent effort to determine the ability of the Participant to engage safely in the Equine Activity or manage safely the particular equine, and/or the result of a dangerous latent condition, as well as: (i) The propensity of an equine to behave in ways that may result in injury, harm, or death to persons on or around them (ex.: jump, run, kick, buck, bolt, spin, rear up, strike, bite, stumble, fall, etc.); (ii) The unpredictability of an equine's reaction to sounds (ex.: machinery, equipment, doors, rain, wind, thunder, voices, ATV's, gun shots, cars, trucks, snakes, etc.), sudden movement (ex.: rider falling, loose horse, loose dogs, etc.), and unfamiliar objects (ex.: jumps, poles, barrels, flowers, water, flags, golf carts, etc.), persons (ex.: riders, visitors/guests, spectators, etc.), other animals (ex.: leashed or unleashed dogs, cats, wildlife, ground squirrels, etc.), or other things; (iii) Certain hazards such as surface and subsurface conditions (ex.: ground holes, uneven terrain, slippery, hard, or deep footing or flooring, construction material, other dangerous latent conditions of the property, etc.); (iv) Collisions with other equines or objects; and (v) The potential of a participant to act in a negligent manner that may contribute to injury to participant or others, such as failing to maintain control over the equine, or not acting within his or her ability. Participant understands the Loss that may result from the accepted risks of engaging in Equine Activities or just being near an equine, that equines are powerful and potentially dangerous, even without warning, and that the risks listed in this Release are just a sampling and Participant is not relying on Released Parties to list all possible equine-related risks. Participant agrees that no warranties or representations as to the condition or safety of The Horse Park at Woodside ("**HPW**") facility have been made. Participant agrees that engaging in Equine Activities under this Release includes, but is not limited to, those defined under California law, as well as petting, leading, feeding, watering, bathing, and/or grooming an equine, observing an Equine Activity, or assisting with any of these activities, and otherwise interacting with or merely being in the vicinity of equines (collectively "**Equine Activity**" or "**Equine Activities**"). Participant understands and agrees that HPW requires the wearing of an ASTM-standard F1163/SEI-certified equestrian helmet ("**Helmet**") for anyone riding an equine. Participant is not relying on Released Parties to provide, check for proper fitting, or monitor the wearing of, a Helmet. Participant agrees to execute this Release and accepts responsibility for its execution by anyone at the HPW facility at Participant's request, invitation, or permission, whether or not they are engaging in Equine Activities. Participant agrees to at all times to be responsible for his/her personal health and safety, to purchase and maintain his/her own insurance, remain financially responsible for his/her medical expenses, and waives his/her right to any claims arising from participation in or observation of any Equine Activities or merely being present on property owned, leased, rented, visited, organized upon, or otherwise occupied or utilized by the Released Parties, regardless of the reason for Participant's presence at the HPW facility. The following shall be included as Released Parties under this Release: HPW and its subsidiaries, agents, assigns, trustees, employees, employers, directors, officers, volunteers, contractors, guests, visitors, members, managers, or others acting on their behalf (collectively "**Released Parties**"). Participant acknowledges that he/she hereby waives on his/her behalf and on behalf of his/her heirs and assigns, and fully understands the effect of such waiver, all benefits flowing from any state statute that would otherwise limit the scope of this Release, including but not limited to **Section 1542 of the California Civil Code**, which provides: "A general release does not extend to claims which Participant does not know or suspect to exist in his or her favor at the time of executing the Release, which if known by him or her must have materially affected his or her settlement with the Released Parties."

2. 3. Governing Law/Time Limitation/Attorneys' Fees/Jury Waiver: This Release shall be construed and enforced in accordance with California law. All disputes relating to the interpretation and enforcement of this Release shall be resolved exclusively by the state court in Santa Clara County, CA. Participant submits to this jurisdiction and venue for such purpose. Participant agrees that this Release does not expire and that any and all claims and/or causes of actions for Loss by Participant against the Released Parties surviving this Release must be brought within one (1) year of the date the Loss occurred, and any claim for personal property Loss is limited to Two Hundred Fifty Dollars (\$250). Participant agrees to reimburse Released Parties for any attorneys' fees and costs incurred by Released Parties in enforcing this Release and/or in defending or prosecuting any claims or causes of actions involving, or in any way relating to, Participant. Participant agrees to waive trial by jury in any action, proceeding, or claim brought by Participant against Released Parties on any matters related to, arising out of, or connected with this Release.

4. Severability/Modification: If any provision of this Release or its application is determined invalid or unenforceable, neither the remainder of this Release nor the application of such provision shall be affected thereby. Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. The minimum percentages are as follows:

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

or

- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.
